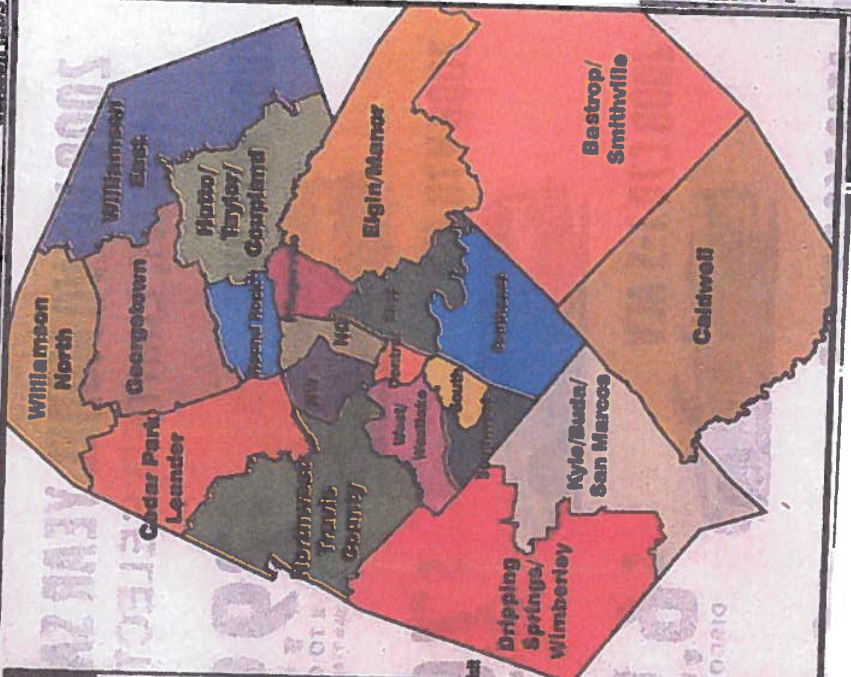


REAL ESTATE LOCATOR MAP
