I spoke with Keith Graf this morning, our Director of Aerospace & Aviation, and he suggested that you contact the Texas Department of Transportation Aviation Office. Dave Fulton is their Director but Keith said it may be better to reach out to Bill Gunn in their office. Keith said that our office probably doesn't have any incentives at this point since this is a privately funded airport, but also suggested to contact Larry Silvey on his staff to further explore some possibilities. I'm copying Larry S. on this so he will be aware of these discussions.

Another point person who had told me several months back that Jim needs to get the 381 Agreement signed before the State can seriously consider any type of assistance is Larry McManus (whom you probably know), so I would also contact "that" Larry as well. I would start here and see what these gentlemen have to say so Jim will have a better understanding of what type of potential for assistance may be available. Dennis, Larry;

I am exchanging your respective contact information so you can get together.

Larry, Dennis is the Economic Development Director for Elgin and is familiar with airports as economic development generators from previous work with Caribbean countries that depended upon the airport for their commerce. Dennis has offered to head the effort to get a letter from the Bastrop County Commissioners Court or Judge to the Governor's office requesting assistance with all of the various forms of support, funding and contacts that could be available.

This weekend I received a request for education donation assistance from a former school board official at Bastrop ISD that advised me that Bastrop has a 25% illiteracy rate and over 60% of the school children are from economically disadvantaged families. This is a staggering statistic for central Texas and only 16-miles from the Texas State Capital. Education, job creation and economic development are what The Perryman Group point out in the Economic Assessment for Central Texas Airport and Green Corporate Centers.

We have a Japanese based solar company coming in to meet with us at 2pm tomorrow. Eco-Merge wants to strike a deal to build and operate a 3-4 megawatt solar generation facility at Central Texas Airport. They say they can deliver the power purchase agreements with LCRA and Bluebonnet if we can get some of the \$2B in alternative energy/sustainable community project funding from the Governor's office. We have an additional sweetener in seeking this type of funding. Our CTA-GCC project needs the power in a remote location (that airports require) but our project is a unique economic engine that creates employment at unprecedented levels for a very poor Bastrop County community and area school districts. Larry, this area suffered through 3 ½ years of exceptional drought which further ravaged the already struggling agricultural industry. If the Governor's office helps get this funding for this solar infrastructure asset Bastrop County will have trumped the City of Austin's failed Pecan Street Project and \$250mm solar project on its Austin Energy tract in Webberville. We will build the first green airport in America and first sustainable commercial campus (real-time smart grid community) with newly patented technology that Tiga brings. This creates the base for our "smart grid" jobs in addition to those generated as a result of the airport.

This is just one example of areas of assistance that could be available that could have a huge positive impact on our airport project and the types of employers that we can attract to Green Corporate Centers if we have solar power that can be blended with Bluebonnet grid supplied power and State/Federal funding to give us an attractive cost of energy for our project. This same company is doing a deal with Brownsville/CPL for a 30 Mw solar generation facility. Our law firm out of San Antonio introduced us to the Eco-Merge folks which are their clients. We in turn brought in Tiga Energy Services (our technology partner on CTA-GCC) to meet them. Tiga and
